Message of Head of Judge

Hong Kong should gear up and drive the digital economy

The World Bank estimates that the digital economy contributes to more than 15% of global gross domestic product (GDP) and expects it will grow tremendously and contribute 30% to the global GDP by 2030.

With the popularity of emerging technologies such as the Internet of Things, blockchain and artificial intelligence, many countries have moved steadily to embrace digital economy with more proactive attitude.

In recent years, many ASEAN countries with close commercial and trade relations with Hong Kong have developed internet and virtual currency rapidly. The World Economic Forum states that ASEAN is the fastest growing internet market in the world, with 125,000 new users every day. It is expected that the ASEAN digital economy will bring US\$1 trillion to the region's GDP over the next 10 years.

According to the 2022 Global Crypto Adoption Index, among the 154 countries, four ASEAN countries rank in the top 20, including Vietnam (1 st), the Philippines (2nd), Thailand (8 th), and Indonesia (20th). Therefore, to grosp the huge opportunity of the ASEAN market in FinTech and smart city services, it is essential for Hong Kong to develop digital economy with virtual assets.

What's more, to maintain Hong Kong's competitiveness on the global stage, it is necessary to attract more local and overseas companies to embrace FinTech and develop related business. We must gear up and nurture more talents to unlock their full potential of FinTech, especially in the area of green tech and green finance. Then, we can cement Hong Kong's status not only as an international financial centre, but also the Asia's premier FinTech and green finance hub.

Let's work together to co-create a brighter future for Hong Kong.
